APPLICATION TERMS AND CONDITIONS

This application is for the purpose of requesting a subsidy of registration and accommodation costs. New Wine's purpose in offering this facility is to alleviate financial hardship to enable attendance at a New Wine Summer festival. No cash support is provided nor will full funding be given. Requests for subsidies are confidential and will be considered on a case-by-case basis.

Applications submitted indicate consent to the terms and conditions detailed below.

All subsidy applications must be preceded by a festival booking form.

New Wine will extend the early bird closing date to 31 December for all subsidy applicants who have paid 50% of their fees by 1 December.

In considering applications, New Wine may make any enquiries it sees fit.

New Wine subsidized registrations will be approved on the basis of tent site or off-site (basic) accommodation. Where requested and available bunk accommodation may be considered. Medical considerations and physical disabilities will be taken into account for an accommodation upgrade.

Medical considerations and physical disabilities withstanding, New Wine will subsidise registrants with tent site as appropriate, or bunk accommodation where requested and available.

New Wine is under no obligation to grant any subsidies but will equitably consider all applications.
